13. NEW BUSINESS

A. Planning and Zoning Board Reorganization

Council Member Nelson stated that she agrees with the timeliness of it and she wants to make sure that everyone has full understanding of what's going on. She said that if we went with all of the recommendations they gave then we would have an issue because then the board would be the one making the decisions, without council approval, however, as of now the board is who gives the recommendation. She stated that when she was on the board it was an opportunity for her as a citizen to get involved and figure out what was best for the entire city, and she doesn't 100% disagree with putting employees or maybe ex officio's just to view. She also stated that she would love to see the members who want to stay-stay, and that we need to have committed people as well and if business owners are going to be apart of the board they need to live in Port Wentworth.

Council Member Bright stated that another issue with the board is that because it is voluntary most people don't show up for things such as training, and he stated that they have to want to do it.

Council Member Nelson stated that Carl Vinson does offer training and they will come but there is a fee, and Mayor Norton said that he doesn't see why we shouldn't have them come out, Council Member Nelson then said that in addition to that we should also have in house training. She also stated that she doesn't want to exclude anyone just because of the knowledge that someone may not have.

City Manager Davis explained that it would be an advisory board and that there wouldn't be a shift in power. He also stated that the idea of including department heads/employee will help with the familiarity of any issues when doing planning and zoning. He also explained that the new assistant city manager would be the chair of the board as he will already be overseeing the development services and has a background in planning and zoning.

Council Member Smith asked why not have the employees be apart of an advisory board or be non voting members, this way we get the knowledge that we need.

Council Member Jones stated that the planning board is the frontage for council they help catch things before they come to council. He also explained that the by having the professionals on the board the citizens and the professionals can feed off of each other when making decisions, and it will also help with the amount of people committed the work of the board.

Council Member Barbee stated that we should bring the board up to the 21st century and that there isn't really an issue of power balance because they will just be advising us and not making the final decision.

B. Real Estate Donation

City Manager Steve Davis explained that Richmond Baptist Church's right away is right as the tip of the highway, and that the council wanted to donate land to them, however, due to constitutional issues dealing with the separation of church and state, we cannot physically just donate the property. However, he has spoken with the pastor about the different options that could be taken and they have decided to move forward with purchasing the property outright.

C. Real Estate Purchase

The City Manager explained that this piece of property is adjacent to the property that is currently owned by the city for the park and the property would give access to highway 30. The City Manager has talked and negotiated with the owners of the property and stated that we needed two month for due diligence (obtaining a nationwide permit from EPD which is a formality) and temporary access to the park so that we can get started, and they have agreed to work with us on every aspect, so we are asking for authorization to purchase the property.
