City Attorney Stated that this ordinance will replace the old one as it has not been updated in years. State law has changed in many ways with respect to alcohol and packaging. This ordinance will base the amount package stores on the population. Stating that for every 5,000 people by the official census being added to the population we can add a package store. However, we cannot take anyone's license away as they are already vested.

A. Site Plan Review Application submitted by Claret Communities, LLC., for PIN # 7-0976-02-027 (Highway 30) for a Specific Development Site Plan to allow a Multi-family Development (Noble Vines Phase 2) in a P-RIP (Planned Residential Institutional) Zoning District

A representative from Thomas and Hutton came and explained that he was speaking on behalf of Phase 2 of Noble Vines. He also stated that planning commission also recommended approval, and asked if council would approve as well.

Councilwoman Nelson asked how many units were there going to be and he said phase 1 has 60 town homes and Phase 2 has 102 town homes.

Councilman Stephens asked if these were going to be for rent or sale and he said for sale.

Councilman Nelson asked where the water is going to go, and he stated that the out fall is to the south end of the site where there are several culverts that they will be tying into with the proposed lagoon for phase 1 and phase 2 doesn't propose anymore lagoon.
