A. Site Plan Review Application submitted by Forestar (USA) Real Estate Group Inc., for PIN # 7-0906-04-042 (Lakeside Blvd.) for a Specific Development Site Plan to allow a Single-Family Subdivision Development (Rice Hope Lakeside Phase 24) in a M-P-O (Master Plan Overlay) Zoning District

Jason from Pittman Engineering came on behalf of the developer and stated that phase 24 is an extension of the phases that are currently being developed apart of lakeside, and there is infrastructure to support this project.

A. Designation of Primary Bank/Financial Institution

City Manager Davis explained that the City has been with the same bank for years and it has very limited capabilities based on the processes that we've been putting into place this year. Truist is one of the largest banks in America and their capabilities align with our processes.

Mayor Pro-Tem Barbee stated that he was glad that we reached out to and researched multiple banks to pick the best one.

Councilwoman Nelson explained that there has been some issues with our current banking institution that was very discouraging. She also stated that she brings up often the value of people being good community partners and they have never checked that box. However, she is glad to see that financial literacy has been happening in our community through Truist Bank as they have been co-hosting financial literacy seminars educating the families of this community.

Councilman Stephens explained that the return on our investment with the current banking institution has been abysmal, so he is in favor of the re-designation.
