Scott Monson from Thomas and Hutton Engineering Company gave a presentation for the Subdivision Application Wentworth Grove Phases 1, 2,3 Preliminary Plat.

Councilman Jones asked why the homes will be for rent instead of affordable housing for people to buy the homes, and the developer Todd Anderson explained that they are in the rental business and through their experiences with the national property management firm has shown that there has been a lot more tenure in these homes than you will find in a typical apartment project. Also, in this time period people are looking for a little more flexibility and this will allow them to have that. He also stated that if approved they do have the option to change it to for sale in the future.

Mayor Pro-Tem Barbee stated that he appreciated their business concept, and explained that there will be homes for sale from the Habitat of Humanity and in Rice Hope.

Councilman Stephens asked what was the current status on the development agreement between them and the City, and the City attorney explained that was something that was discussed at the planning and zoning meeting stating that as long as that do everything that they need to do the City will be able to take over things such as the roads and infrastructure. He also stated that we do not need to create another contract because it is covered in the law. Councilman Stephens also asked if they had reached out to any of the companies in the city and they said yes through their property management group.
