4. NEW BUSINESS

A. Chatham Area Transit Authority Agreement to Run A Daytime St. Patrick's Day Shuttle Service

Phillip Claxton, City Administrator, discussed the two (2) proposed agreements between Chatham Area Transit Authority (CAT) and the City of Port Wentworth. In summary, the proposals offered the City of Port Wentworth an opportunity to partner with CAT to run a daytime shuttle service, either every hour or 1/2 hour depending on the vote of Council. The shuttle service would include two full size shuttles/buses for a flat round-trip fee of \$5 for Port Wentworth residents. The suggested pickup/drop-off location would be behind the Food Lion Shopping Plaza in Port Wentworth. Advertising for the shuttle would be done by publicizing on the City Hall marquee, City website, myEmma (email blast), social media accounts, and Home Owners Associations Boards within the various Port Wentworth neighborhoods.
