CITY OF PORT WENTWORTH FIRE PROTECTION FREQUENTLY ASKED QUESTIONS (FAQs)

WHAT IS A FIRE PROTECTION FEE?

A fire protection fee is a charge for fire protection and emergency management services provided by the City of Port Wentworth Fire Department (PWFD) to all properties within City limits.

WHO IS REQUIRED TO PAY A FIRE PROTECTION FEE?

All properties and utility customers with the City of Port Wentworth are required to pay a fire protection fee.

WHAT SERVICES DOES THE PWFD DELIVER TO MY PROPERTY?

Services include: Fire response, search & rescue operations, accident response, vehicle extrication, emergency management, hazardous materials mitigation, fire inspections, wild land fire control, maritime firefighting and rescue operations, preplanning and fire plan preparation, fire prevention, fire & safety education, training & orientation.

CAN I HAVE A PWFD FIRE FIGHTER COME TO MY PROPERTY/BUILDING/SITE TO PERFORM A FIRE INSPECTION?

WHERE IS THE PWFD LOCATED?

The PWFD currently provides fire-fighting services through two Fire Stations located at 319 Cantyre Street and 6781 Highway 21.
